#### 1. SUMMARY OF FINDINGS

Subject KALMAN was observed on six (6) separate occasions transporting unmarked corrugated cartons from a third-floor stockroom at 874 Madison Ave to a rented locker (Unit 7-G-22) at Manhattan Mini Storage, 520 W 17th St. On May 11 at approx. 14:37 EDT, operative Caruso observed KALMAN accepting delivery of 3 cartons labeled „KLOTZ TEXTILES LTD · KAUNAS (LT)”. #### 3. CONCLUSIONS

The evidence gathered during the 14-day surveillance period supports the conclusion that A&K Boulevard Boutique LLC is sourcing silk scarves from „KLOTZ TEXTILES LTD, Kaunas (Lithuania)” — a supplier connected to the UAB klotzkettie corporate network — and marketing them using descriptors that infringe on the KLÔTZZKÈTTÉ trade dress. The removal of the brand name label after our initial C&D; letter (May 7 awareness) suggests awareness of the infringement.
